# X. Quality Audit Service

The AC members took note of the update on QAS' activities as regards the 12 assessment visits in 2014, the practical arrangements for the audit fee following the agreement reached on the subject at previous meeting, the proposed modification in the planification of the Internal Audits of QAS in the revised version of the QAS Procedure manual and the call for tender for the appointment of QAS Technical experts for 2015-2018.
