Dear readers.

Welcome to the new digital newsletter of the Community Plant Variety Office!

The format has been modernised and it will be published more regularly so that it is up to date with our latest news. We hope that this will contribute to further engagement with you, our closest professional partners, institutional stakeholders and users of the EU plant variety protection system.

2020 has been a very challenging year for all of us because of the COVID pandemic. We are now in constant virtual meetings and we are missing the joy of being together.

It was quite disappointing that the pandemic disrupted our 25th anniversary and we had to cancel a big event during which we could have boasted about the achievements of the EU Plant variety protection system: since 1995, the CPVO received over 70 000 applications and granted 55 000 plant variety rights, among which nearly 30 000 titles are currently in force.

We received many messages from our stakeholders recalling the benefits that the system brings to them and we are happy that the CPVO is well recognised and valued across the EU and beyond. Thank you!

We are equally pleased that the industry continues to be productive: last week the CPVO processed its 3000th application in 2020. A figure slightly lower than what we did in 2019, but still very high.

The pandemic has forced us to rethink how we do things. I was particularly impressed by an online training for Chinese experts on DUS testing coorganised by the CPVO last month. Due to the pandemic, six European Examination Offices filmed their assessment of different varieties in the fields and in glass houses from March to August. The footages were shown during the virtual training and complemented the usual power point presentations with a new dimension.

Let's remain creative, focused and hopeful. I am convinced there will be brighter days in the near future, and this is all I wish for 2021!

In the meantime, I wish you a pleasant and informative read!

Vacancy notice: President of the CPVO

Given that the second mandate of Mr. Martin Ekvad as President of the CPVO will come to an end on 31 August 2021, a vacancy notice for the role of President of CPVO has been published in the Official Journal of the European Union (Ref: <u>CA 379</u>, 10 November 2020).

The post will be available from 1 September 2021 for an initial mandate of 5 years, with a possible extension for a maximum period of 5 years.

We encourage those of you with a vision to lead an EU Agency in the field of Intellectual Property Rights for plant varieties through the challenges of digitalization and climate change to apply before 10 December 2020, 12:00 noon CET.

Please note that this recruitment process is managed by the European Commission.

IP KEY: international outreach activities

In an effort to promote plant variety protection at global level, the CPVO is taking an active role in the EU-funded IP KEY programme, directed by the European Commission and implemented by the European Union Intellectual Property Office (EUIPO).

In October, the CPVO led an online training on plant variety rights and DUS examinations for a group of 60 experts from China's Ministry of Agriculture and Rural Affairs (MARA) and China's National Forestry and Grassland Administration (NFGA).

The <u>session</u> provided an excellent opportunity for in-depth discussions between the Chinese experts and the European ones, representing the CPVO and six EU examination offices from the Czech Republic, France, Germany, Hungary, the Netherlands and Spain.

In November, the CPVO participated in similar IP KEY activities with experts from South-East Asian countries and Latin American countries, and the CPVO is participating this week in an IP KEY activity on enforcement of plant variety rights with Chinese officials.

Update on BREXIT

In the context of the withdrawal of the United Kingdom from the European Union, the European Commission and the Community Plant Variety Office have published updated guidance for stakeholders regarding the withdrawal of the United Kingdom from the European Union and the EU rules applicable in the field of Community Plant Variety Rights.

The CPVO would like to remind all breeders who are currently domiciled or have a seat in the United Kingdom that they must designate a procedural representative who is domiciled or has his seat or an establishment within the EU territory.

Failing to do so before the end of the transition period (01 January 2021) will lead to the CPVO initiating cancellation procedures of the Community Plant Variety Rights in question.

New search tool for species requirements

The CPVO launched a new search tool for applicants, where users can find the closing dates for applications and the submission requirements per species according to the entrusted examination offices carrying out DUS tests for the CPVO.

For species without an entrusted examination office in the EU, the database contains information about cooperating authorities in third countries.

For those familiar with the CPVO, this new online search tool merges the information formely available in the so-called S2 publication and S3 webpage.

Improved online denomination service

All users of the CPVO services and applicants to Community Plant Variety Rights can now have an overview of the denomination situation over their files and submit their denominations proposals online.

Users must connect to $\underline{\text{MyPVR}}$ to access the new dashboard and use the new e-denominations service.

The CPVO Variety Finder database is currently being revamped and a new version will be released in December.

The new CPVO Variety Finder will feature key improvements, both in terms of usabilty, with a more user-friendly and intuitive design, and in terms of functionalities, with new searching functions and the possibility to use our application programing interface (API).
