Main conclusions

Opening of the meeting, general information and approval of the draft agenda (DOC-AC-2022-1-01)

The Chairperson of the Administrative Council declared the agenda adopted as proposed.

2. Consolidated Annual Activity Report 2021 (DOC-AC-2022-1-02a-c-f + Annexes)

- 1 The members of the Administrative Council took note of the reporting part of the Annual Activity Report for 2021: management report, statistics, social and financial reports and Provisional Annual Accounts 2021.
- 2 The members of the Administrative Council unanimously adopted the AC Analysis and Assessment to be signed by the Chairperson of the AC.
- 3 The members of the Administrative Council unanimously discharged the President of the Office in respect of the implementation of the budget 2020.

3. CPVO Strategic Plan (DOC-AC-2022-1-03 + Annex)

The members of the Administrative Council adopted the retrospective performance report of the Strategic Plan 2017-2021.

The members of the Administrative Council took note of the way forward to the new Strategic Plan 2022-2026 which will be presented at next Administrative Council in Autumn.

4. AC opinion on the draft Single Programming Document 2023-2025 (DOC-AC-2022-1-04 + Annex)

The members of the Administrative Council took note of the Single Programming Document - SPD - 2023-2025. They were invited to send comments in writing to the CPVO by end June 2022. A revised version including the comments received will be presented for adoption at the AC Atumn meeting.

5. AC opinion on the Preliminary Draft Budget 2023 (DOC-AC-2022-1-05 + Annex)

The members of the Administrative Council took note of the Preliminary Draft Budget for 2023.

6. CPVO Building project (DOC-AC-2022-1-06 + Annex)

The members of the Administrative Council commonly agreed on the relevance to launch a local Angers market prospection in view to possibly relocate all the CPVO staff in one single building. No purchase decision shall be taken without prior approval by the AC.

7. Place of employment of CPVO staff (DOC-AC-2022-1-07 + Annex)

The members of the Administrative Council took note that the CPVO is reflecting upon the opportunity, for specific and well-defined tasks, to have a limited number of CPVO staff based and working outside Angers, place of employment. The AC is expecting a detailed document with financial elements and costs/benefits ratio analysis at next AC meeting.

8. IP Action Plan /SMEs (DOC-AC-2022-1-08)

The members of the Administrative Council took note of the state of play of CPVO's initiatives to consider all the existing tools made available under IP tools for SMEs in order to implement the IP Action Plan of the European Commission.

The members of the Administrative Council unanimously adopted the eight revisions of existing technical protocols presented for Eruca sativa Mill. (CPVO-TP/245/1), Diplotaxis tenuifolia (L.) DC. (CPVO-TP/244/1-Rev), Hippophae rhamnoides L. (CPVO-TP/240/2), X Triticosecale Witt. (CPVO-TP/121/3), Secale cereale L. (CPVO-TP/058/1-Rev), Spinacia oleracea L. (CPVO-TP/055/5-Rev.4), Chrysanthemum L. (CPVO-TP/026/2-Rev) and Lactuca sativa L. (CPVO-TP/013/6-Rev.3).

They also took note of the editorial changes to the following five CPVO Technical Protocols: Pisum sativum L. (CPVO-TP/007/2 Rev.3 Corr.), Petroselinum crispum (Mill.) Nyman ex A.W. Hill (CPVO-TP/136/1-Corr.), Cichorium intybus L. var. foliosum Hegi (CPVO-TP/154/1-Corr.), Allium sativum (CPVO-TP/162/1 Final-Corr.), Capsicum annuum L. (CPVO/TP-076/2-Rev.2-Corr.)

18. Update on the cooperation between CPVO and EPO (DOC-AC-2022-1-18 + Annex)

The members of the Administrative Council took note of the signature of a new Administrative Arrangement on 31 March 2022 for 5 years with EPO and of the different actions reported. The members of the Administrative Council welcomed a presentation of the EPO at the next AC meeting on the change of practice in examining patent applications and the impact of CPVO data in conducting prior art searches at EPO.

19. Update on the cooperation between CPVO and EUIPO (DOC-AC-2022-1-19)

The members of the Administrative Council took note of the signature of a Service Level Agreement (SLA) on 12-21 July 2021 with EUIPO for an indefinite period on a number of major areas such as Internal Audit, Data Protection Officer, IT related services, HR services, trainings and activities linked to the Observatory and the Academy.
